Removal of a Scholarship

- You are expelled, suspended or excluded from the whole or part of the Davidsbündler Music Academy or your program of study for academic failure; or
- We are of the reasonable opinion that you have made any misrepresentation (whether negligently or intentionally) to us either in respect of applying for the Scholarship or during the course of and in connection with your studies at the Davidsbündler Music Academy; or
- We are of the reasonable opinion that you have acted fraudulently or dishonestly in connection with securing your Scholarship or place at the Davidsbündler Music Academy.

In the event of an intercalation, payment will be suspended until you return and progress to the next stage of your course.
